In compliance with article 74 § 7 and § 8 of the Law of 1 April 2007 on public take-over bids (the “Law”) we informed you on 18/02/2008 that a number of parties acting in concert jointly held more than 30 % of the voting securities issued by Etablissementen Fr. Colruyt NV (the “Company”) on 1 September 2007.

Please find herewith an update as per 25/08/2023 of the different shareholdings in conformity with article 74 § 8 of the law mentioned above.


