Dear members of the Board of Directors,

In compliance with article 74 § 7 and § 8 of the Law of 1 April 2007 on public take-over bids (the "Law") we informed you on 18/02/2008 that a number of parties acting in concert jointly held more than 30 % of the voting securities issued by Etablissementen Fr. Colruyt NV (the "Company") on 1 September 2007.

Please find herewith an update as per 26/08/2021 of the different shareholdings in conformity with article 74 § 8 of the law mentioned above.

This notification is sent to you in the name and on account of all parties acting in concert.

 Société de Participations Industrielles SA and Mobilière et Immobilière du Centre. SA
- Based on the existing agreements, the mutual consultation agreement between the Colruyt family and relatives and Colruyt Group on the one hand and Sofina NV on the other will expire not later than the end of September 2021. This does not affect the mutual consultation agreement between the Colruyt family and relatives.
